

Please be advised:

In the period from May 21st to August 31st, the local authority of Amsterdam will be conducting necessary construction work on the Europaboulevard.

The RAI Amsterdam is closely involved in this project, and we aim to minimize inconvenience. However, during the 20th World Congress on Pain! Exhibition, a section of the road to the RAI will be closed off. The diversion route will be indicated by the well-known yellow signs. Additionally, below is a map indicating the construction work during the 20th World Congress on Pain for reference.

It is inevitable that there will be some inconvenience and possibly longer arrival and departure times. We are continuing to consult with the local authorities of Amsterdam to ensure that the disruption is kept to a minimum.
